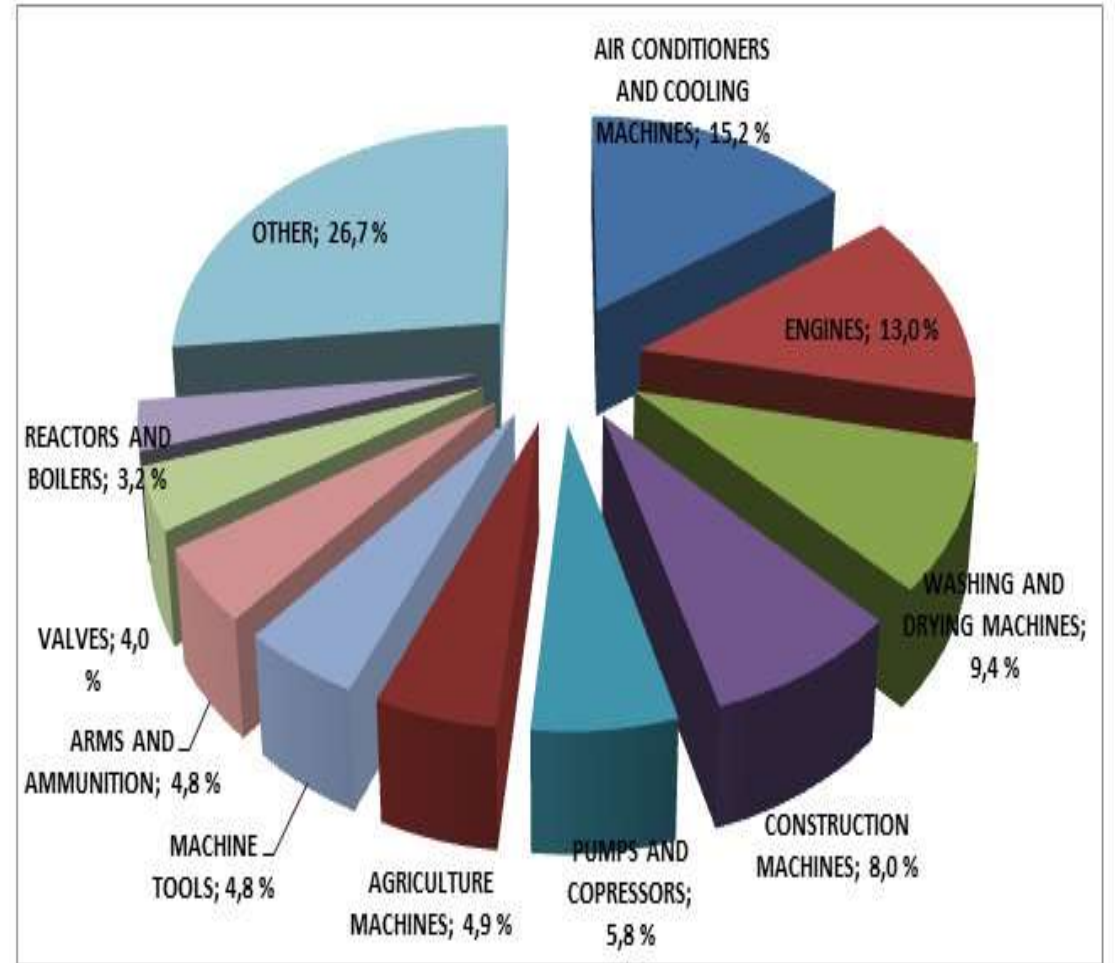

HOW TO OBTAIN TURKISH CITIZENSHIP BY INVESTMENT

STEP1

Once this has been completed and you are happy to proceed, you can formally initiate the process by signing our Client Facilitator agreement and paying the pre-application deposit.

STEP3

This can be done remotely, or by visiting Turkey. Once you have chosen your property you can then apply for a residence permit for all family members and open a Turkish bank account.

STEP4

Once you have completed the property investment, we can submit the application to the government with all relevant documents and certifications. Following a government review of the application citizenship normally takes 3-4 months to be issued.
